





1. **Project Title:** Human–Wildlife Conflict Management and Eco-Development of Forest Fringe Villages – Hunsur Forest Division

2. **Implementing Agency:** Karnataka Forest Department.

3. **Project Location:** Forest fringe villages across all Ranges of Hunsur Division

4. **Objective:** To promote coexistence and reduce human–wildlife conflicts through integrated conservation and community development initiatives.

5. Scope of Work:

- Habitat improvement and creation of water sources.
- Installation of solar fencing and maintenance of elephant proof trenches.
- Livelihood enhancement programmes for local communities.
- Awareness and education activities in fringe villages and schools.
- Provision of rapid response tools and conflict management infrastructure.
- Construction of community eco-infrastructure for long-term sustainability.
