

PROJECT NOTE

1. Introduction

The existing Anti-Poaching Camp (APC) in Kappattagudda Wildlife Sanctuary serves as a key operational base for wildlife protection staff. However, the facility requires significant improvements to enhance functionality, staff comfort, and the overall effectiveness of anti-poaching operations. CSR support for upgrading the camp will ensure better working conditions, strengthen security infrastructure, and improve the aesthetic and functional value of the facility.

2. Need for CSR Intervention

Under Schedule VII (iv) of the Companies Act, 2013, CSR activities related to environmental sustainability and wildlife protection are eligible for funding. Upgrading the APC will directly improve operational efficiency, staff morale, and habitat protection outcomes.

3. Proposed Upgradation Works

- Construction of concwood structures for durability and eco-friendly aesthetics.
- Landscaping around the APC to improve environmental integration and reduce soil erosion.
- Installation of water facilities, including a borewell for sustainable water supply.
- Full building repainting for protection and maintenance.
- Construction of one pergola for shade and community interaction space.
- Installation of electricity connection with transformer (TC) for reliable power supply.
- Additional minor repairs and safety improvements.

4. Expected Outcomes (Measurable)

- 100% functional infrastructure for staff accommodation and operations.
- Sustainable water supply meeting 100% of daily operational needs.
- Reliable electricity ensuring 24x7 power availability for surveillance and operations.

5. Implementation & Monitoring

The Karnataka Forest Department will oversee execution through government procurement processes. Progress updates and final completion reports will be submitted to the CSR partner. Maintenance will be managed by the department's anti-poaching unit.

6. Conclusion
