LED lights, 300 W solar PV systems with batteries and controller. ● Landscaping & Visitor Node: 250 m² native plantation, 90 m² cobble/paver hardscape, 120 Rm drip irrigation line. ● Wayfinding & Branding: Stainless steel letters/logo (10 m² face area), 1 interpretation/map panel, 2 QR sign plaques.

Key Outputs

- **Construction of Entrance Arch** with granite/laterite cladding and bilingual signage (Kannada & English).
- **Solar-Powered Lighting** for sustainable night visibility.
- **Landscaping & Visitor Information Node** with native plants, paving, and interpretation signage.
- **Branding & Wayfinding** with Karnataka Forest Department logo and welcome board.

Justification

- Absence of a **gateway landmark** leads to confusion among tourists and unsafe halts on highways.
- The arch will serve as a **permanent eco-tourism symbol**, improving visitor experience and promoting conservation awareness.
- Supports **CSR commitments** towards environmental conservation and sustainable tourism.

- **Maintenance:** Quarterly inspection and upkeep by Forest Department


