# PROJECT NOTE

## 1. Introduction:

Kappattagudda Wildlife Sanctuary, located in Gadag District, Karnataka, is a unique biodiversity hotspot known for its rare floral diversity, medicinal plants, and habitat for several species of wildlife, including migratory birds and small mammals. The sanctuary's terrain is challenging, spread over [area in sq. km], with a combination of hills, grasslands, and water bodies.

Efficient patrolling, wildlife monitoring, and rapid response to threats such as forest fires, poaching, and illegal tree felling require adequate mobility infrastructure. Presently, the sanctuary faces an acute shortage of suitable vehicles for protection staff, leading to gaps in surveillance and delayed action in emergencies.

## 2. Need for CSR Intervention

Under Section 135 of the Companies Act, 2013, Schedule VII (iv), "*Ensuring environmental sustainability, ecological balance, protection of flora and fauna, animal welfare, conservation of natural resources*" is an eligible CSR activity. Supporting protection vehicles directly contributes to the long-term conservation of Kappattagudda's rich biodiversity.

## 3. Objectives of the Project

- Strengthen patrolling efficiency and coverage in vulnerable areas.
- Enable rapid response to forest fires, wildlife emergencies, and illegal activities.
- Enhance mobility for field staff in remote and rugged terrain.
- Improve community engagement and awareness through mobile outreach programs.

## 4. Project Components

The proposal seeks CSR funding for:

- **Two (01) Four-Wheel Drive Vehicles (Bolero Camper / Gypsy / equivalent)** – for round-the-clock patrolling.
- **Two (01) Isuzu Vehicle** – for Local rapid mobility with staff in Terrain Forest tracks.
- **Vehicle Accessories** – GPS trackers, communication radios, and safety equipment.
- **Branding** – CSR acknowledgment with company logo on vehicles as per Government guidelines.

## 6. Expected Outcomes

- Increase in patrolling frequency by 50% within one year.
- Reduction in illegal activities such as poaching and tree felling.
- Faster emergency response time by at least 40%.
- Enhanced protection of endangered flora and fauna in Kappattagudda.



## 7. Implementation & Monitoring

The project will be implemented by the Karnataka Forest Department, Gadag Division. A monthly progress report on vehicle usage, patrolling coverage, and key conservation outcomes will be shared with the CSR partner. Vehicles will be maintained and operated by trained protection staff.
